I/We understand that the Employer is not bound to accept the lowest or any tender which may be received, and we acknowledge that the Employer has no liability whatsoever in respect of any expenses or losses which may incur in preparing this tender and attending any post tender meetings with the Employer.
5. I/We agree to provide a performance bond equal in an amount specified in the Appendix to Conditions of Contract for the due performance of the Contract in the Specimen form of Banker's Guaranteed issued by a Bank valid from the date of Letter of Award till expiry of Maintenance Period.
6. I/We agree that the Employer reserves the right to accept part or whole of the tender without adjustment to the rate quoted. We shall not claim any loss of profit or interest or any cost for omission or acceptance of such works.
7. I/We confirm that the Tender Sum and the unit rates, prices and costs submitted in this Tender are exclusive of any tax charge under, or by virtue of, prevailing Goods and Services Tax Act or any amendment or re-enactment thereof on the supply of goods and services made under this contract.
